## Care Resource's \$100 Million Economic Impact


Florida's federally qualified health centers (FQHCs) have provided comprehensive, culturally competent, high quality primary health care services to medically underserved communities for more than 50 years. Florida's 49 FQHCs treat 1.5 million patients at more than 500 locations statewide. Sites also include mobile medical, dental, and vision units.

Care Resource Community Health Centers, Inc. operates five locations within Broward and Miami-Dade Counties. These sites provided 44,700 visits to 13,000 unduplicated patients in 2018 – of which 88.6% of patients reporting incomes were at or below 200% of the poverty level and well over half of patients were either covered by Medicaid or had no insurance.

Using IMPLAN modeling software, the state primary care association, the Florida Association of Community Health Centers (FACHC), has determined the overall estimated economic impact of Care Resource CHCs in 2018 was \$100.0 million.


There is an additional return on investment of \$0.73 for each \$1.00 invested in Care Resource.

## Economic Impact of Care Resource 2014 - 2018



Care Resource Community Health Centers acts as a valuable employer, accounting for 514 jobs in 2018 throughout their service area. In addition to the 209 positions at the health center (direct jobs), the five locations also contribute to 304 additional indirect/induced jobs as a result of respending of monies throughout the community, at large.

Care Resource is a 501(c) (3) nonprofit organization and a Federally Qualified Health Center (FQHC). We have seven (7) facilities, including: Miami-Dade, Little Havana-(Miami-Dade), Miami Beach and Fort Lauderdale. We provide comprehensive health and support services to address the full health care needs of our pediatric, adolescent and adult populations.

Rooted in the 1998 merger of Health Crisis Network (1983) and Community Research Initiative (1989) – Care Resource became South Florida's oldest and largest HIV/AIDS service organization. In 1999 primary medical care was implemented and, in 2009, Care Resource became a Federally Qualified Health Center with offices in Fort Lauderdale, Midtown Miami, Little Havana and Miami-Beach, offering general primary care services to the whole South Florida community.



Presently, we took our model of excellence and expanded it to include not only those with HIV, but all of South Florida's diverse communities. Moreover, we have been recognized as a 2015 Leader in LGBT Healthcare Equality by the Healthcare Equality Index and our work in the community has earned us the confidence of our clients as well as public and private funding at local, state and federal levels.

The Florida Association of Community Health Centers (FACHC) is designated as Florida's Primary Care Association (PCA). The primary mission of FACHC is to improve access to quality health services by bringing together agencies, legislators and key persons able to affect health care services.
